

Minutes for the DRSC meeting held on 05-03-2024 in the Conference Hall of District Commissioner office, West Karbi Anglong

The meeting opened with a welcome address from the honourable District Commissioner and the following were the major points discussed-

- There should be adequate jungle cutting and clearance
- Appropriate signages to ensure that road accidents are minimised. In that regard, a notice would be soon floated calling for bids
- List of roads requiring speed breakers, signages, convex mirrors be given by PWD(Roads) so that the areas coming under black spots be minimised
- Discussions to be held with DTO regarding putting of glow signages/stickers in e rickshaws to minimise accident
- Frequent and regular naka checking and fines to be imposed for traffic rules violators
- Awareness and campaigns in schools to enforce the same
- DTO to employ Motor vehicles inspector on a regular basis in West Karbi Anglong district to enforce all appropriate rules under MV act. He is also asked to be present in all future DRSC meetings in the future
- To ensure that the health sector has adequate facilities for road accidents and trauma centre facilities to be developed.
- To ensure that the forest department take steps to ensure that the felled trees do not create an obstruction for the traffic management
- To ensure that the action taken reports are submitted on time and timely steps are taken

1	Providing and fixing of retro-reflectorised cautionary, mandatory and informatory sign as per IRC:67 made of encapsulated lens type reflective sheeting vide Clause 1 7012.3 fixed over aluminium sheeting, 1.5 mm thick supported on a mild steel angle iron post 75 mm x 75 mm x 6 mm firmly fixed to the ground by means of properly designed foundation with M1 5 grade cement concrete 450 mm x 450 mm x 600 mm, 600 mm below ground level as per (i) 600 mm equilateral triangle (ii) 600 mm circular (iii) 600 mm x 600 mm square
2	Convex mirror to be used as Signage
