The tenders will be received in the drop box at the Election Branch, O/O the Deputy Commissioner, West Karbi Anglong, Hamren on behalf of the undersigned till 2:00 PM upto 04-05-2022 and shall be opened on the same day at 3:00 PM in presence of the Tenderers or their authorized representative.

Terms and Conditions :-

1. The Sealed envelope should be written as "Quotation for hiring of CC Camera Items for KAAC Election-2022".
2. The tender are invited to determine a competitive and reasonable rate for Supplying items enclosed at Annexure-A.
1. The Firm / Persons should be furnished attested copy of Firm Registration Certificate, PAN Card, Trade License and GST Registration Certificate, Financial soundness certificate, Previous work order (if any) etc. along with tender and the drop the tender in the drop box kept in the Office of the Deputy Commissioner of West Karbi Anglong, Hamren.
2. The rate should be quoted inclusive of all taxes (including GST).
3. The Quotationer / Tenderer to whom works are allotted will have to execute a bond / undertaking as per Rules.
4. Any deviation of terms and conditions shall invite cancellation of Quotation / Tender / Bills etc.
5. An amount of Rs. 10,000/- (Ten Thousand) only will have to deposited as security money in form of a call deposit in favour of the Deputy Commissioner & District Election Officer, West Karbi Anglong, Hamren and the same shall be refunded at the time of payment of Bill after proper adjustment, if any.
6. Bill may be submitted along with necessary work order and copy of completion certificate by Authorized Officers for payment.
7. Payment will be made on getting fund from the Govt. of Assam from time to time.
8. The approved Firm / Contractor will have complete the above mentioned work as and when required under short notice and in due time without fail.
9. The work may be allotted to one or many firms / contractors depending upon the urgency of the work time factor, quality of the works and past record of the Firms / Contractors for doing and the works in due time as per the rate fixed.
10. Selection firms / contractors cannot share/hand over the recording clips / cassette/ pen drive /memory chips/ hard disk etc. to any third party. All such mentioned must be submitted to the Deputy Commissioner, West Karbi Anglong, Hamren or his authorized nominee. After completion of recording, they shall handover the cassettes daily to concerned Authorized Officer.
